6. **RECEIVING OF COMMUNICATIONS**

Mayor Weaver...

...shared a copy of a letter addressed to Debby Heniff and the Citizen of the Year Committee from the Darien Historical Society commending the great job in putting together the Citizen of the Year dinner dance on March 7, and expressing gratitude for honoring the Historical Society's 35th anniversary.

...advised that she and Alderman Galan received correspondence from Todd McDaniel of 318 69th Street in the Marion Hills area expressing gratitude to Director Gombac and Superintendent Salvato for the time, attention, and consideration given to him regarding issues with the floodways which are adjacent to his home.

...received a number of appreciative e-mails staff forwarded from residents regarding this year's tree trimming program.

Alderman Avci...

...received a request from Mr. Barry Zelinski of 7322 Bunker for the city to consider installing a new "Yield" sign at Bunker where it intersects with Timber Lane. Mr. Zelinski indicated that there is a considerable amount of traffic on Timber Lane, and those traveling north on Bunker do not always yield.

...received an e-mail from Vince and Anne Livak of 1109 Timber Lane regarding the chronic problem with trash accumulation along the fence on the north and east periphery of the Jewel Foods lot. Alderman Avci forwarded the e-mail to Scott Coren who has since contacted the Jewel Manager. Alderman Avci visited the site yesterday, and even

though it appears some was picked up, trash remains in the area, and near the other stores south of Jewel. The refuse dumpsters were overflowing. Alderman Avci requested staff follow up on this matter.

In response to Mayor Weaver and Alderman Poteraske, Chief Pavelchik advised that “Yield” signs do not have to meet the same strict guidelines as a “Stop” sign. The City, at their discretion and by ordinance, can put up a “Yield” sign with much lower criteria than a “Stop” sign.

Mayor Weaver directed that, following a study, this item be brought to the Administrative/Finance Committee for review.

Alderman McIvor advised that there was a similar situation in Ward 6 at Havens and Stewart. A “Yield” sign was installed at that location, and has proven to be very effective.

Alderman Galan received a call from John Becht of 6709 Crest complaining about the drainage in his yard. Mr. Becht brought this issue to the attention of the city one year ago. Director Gombac investigated, and found that, for an unknown reason, the complaint was never addressed. Alderman Galan and Director Gombac met with the resident. In working with the state, Director Gombac was able to determine the source of the problem, and city staff were able to rectify it. Mr. Becht was very pleased with the outcome.

Mayor Weaver received a call from Arleta Peknik advising that arrangements have been made with the library to set up a computer for any resident who does not have cable access to view council meetings. Mayor Weaver expressed gratitude to Ms. Peknik for her efforts and for providing this information.

7. **MAYOR’S REPORT**

- A. Mayor Weaver read into the record a Proclamation declaring April 19-25, 2009 as “*The Week of the Young Child*” in the City of Darien, and encouraged all citizens to work toward making a good investment in early childhood.
- B. Mayor Weaver read into the record a Proclamation declaring April 12-18, 2009 as “*National Public Safety Telecommunications Week*” in the City of Darien, and by officially recognizing these public safety telecommunications professionals, hopes to awaken public awareness.

Mayor Weaver announced that during the Work Session, it was determined that Items A and B under the Consent Agenda be moved to her report as Items C and D. Mayor Weaver requested one motion and vote for both resolutions.

8. **CITY CLERK'S REPORT**

City Clerk Coleman...

...invited all to attend Coffee with Mayor Weaver on Saturday, April 18, 2009 at the Darien Historical Society at 7422 Cass Avenue from 9:00 A.M. to 10:00 A.M.

...reminded all that the Consolidated Election is tomorrow. The polls will be open from 6:00 A.M. to 7:00 P.M. Aldermanic positions for Wards 1, 3, 5 and 7 are on the ballot.

9. **CITY ADMINISTRATOR'S REPORT**

Administrator Vana provided a brief update on the town center redevelopment project. In response to the city's RFP, four viable proposals have been received. The Planning and Development Committee held a meeting to review the proposals on March 30, 2009. All proposals were done well, and offered very interesting options for development of the property. The preliminary meeting was televised live, and was run four times a day during the last week. A Direct Connect was sent out encouraging residents to view the proposals at City Hall or the library. The Planning and Development Committee has scheduled a Special Committee of the Whole Meeting on April 20 at 6:30 P.M., prior to the Council Meeting, to discuss and review the proposals with the City Council. At that meeting, staff will be seeking direction from the City Council for proceeding with discussions and/or negotiations. One of the issues which will need to be determined is the intent of the developers regarding purchase of the property.

Mayor Weaver noted that several residents have expressed excitement over development of this property. Mayor Weaver encouraged residents to watch the tape of the presentations and provide input.

Alderman Poteraske added that the meeting can also be viewed on the city's website.

Alderman Avci requested expanded input for the residents.

A lengthy discussion took place regarding initiatives already taken and the mechanisms which will allow the continued input from residents on the redevelopment of town center.

10. **DEPARTMENT HEAD INFORMATION/QUESTIONS**

Director of Community Development and Municipal Services, Daniel Gombac advised the City's 2009 Concrete Program is underway. Residents interested in participation should contact Mary Belmonte at 630-353-8102. This year's vendor is Suburban Concrete. Pricing per square foot is as follows:

Alderman McIvor inquired as to this year's percentage increase in cost.

Director Gombac advised that the cost for sidewalks increased \$.05 per square foot, and the cost for driveways, with and without mesh, decreased \$.15 per square foot.

Administrator Vana extended appreciation to Director Gombac for his pursuit in obtaining the \$75,000 in grant funds from DuPage County for Walnut reconstruction.

At Alderman Galan’s request, Director Gombac provided information on the general maintenance being performed by DuPage County Sanitary District from Route 83 to Cass Avenue, and 67th Street to Plainfield Road. The county’s work will continue throughout the summer. Restoration, which includes replacement of sidewalks, landscaping, and replacement of any trees that were removed, will be performed through the city’s program this fall. The county will reimburse the city for all trees that were taken down.

Alderman Poteraske noted that the 2009 Street Program came in \$200,000 under budget.

Alderman Galan inquired if there is a way to obtain bids for road repairs prior to budget meetings so that the Council Members will have a better idea of the costs.

Director Gombac responded that staff has obtained the bids as early as possible.

11. TREASURER'S REPORT

12. **STANDING COMMITTEE REPORTS**

Planning/Development Committee — Alderman McIvor advised that the next meeting of the Planning/Development Committee is scheduled to take place on Monday, April 27, 2009 at 6:30 P.M. in the Council Chambers pending agenda items.

Administrative/Finance Committee — Alderman Poteraske advised that the next meeting of the Administrative/Finance Committee will take place on Monday, April 13, 2009 at 6:30 P.M. in the upstairs conference room.

Public Works Water/Streets Committee — Alderman Marchese advised that the next meeting is scheduled to take place on April 20, 2009 at 6:00 P.M. in the upstairs conference room.

13. **QUESTIONS AND COMMENTS — AGENDA RELATED**

Kevin Monaghan of 7509 Norman Drive addressed the City Council questioning the \$500,000 increase in property taxes. Mr. Monaghan suggested that the proceeds from the sale of the property at 75th and Cass be used, and the property tax be abated.

Administrator Vana provided an historical account of the passage of the tax levy and bond ordinance. It was noted that Mr. Monaghan was treasurer when the discussions and actions took place. Administrator Vana advised that even with the tax levy, the City of Darien's tax rating is the third or fourth lowest in the county. In order to continue the capital projects and level of service, it is necessary not to abate the taxes this year.

Alderman McIvor advised that the tax increase affects her as a resident. The unanticipated catastrophic failure of Walnut could not be foreseen and must be paid. The tax increase is an annual decision that was made for this particular budget year. The city does not know when sale of the property will take place or how long it will take to negotiate with a developer.

Administrator Vana reiterated that the City Council followed a plan that was made previously. The city began a three-year budget forecast a few years ago. Capital projects are based on estimates from staff and requests from residents.

Treasurer Coren advised that the \$500,000 was always scheduled to be repaid by this tax. Last year the city was fortunate enough to be able to abate. Treasurer Coren advised that his recommendation was based on the numbers, and the funds required to provide the residents with necessary services.

Alderman McIvor advised that the tax increase amounts to approximately \$6.00 per month. In her opinion, the price is fair, and allows continuation of city services and infrastructure improvements.

Alderman Gattuso added that the decision was based on the desire to continue to provide the same quality of service.

Mayor Weaver expressed pride in the services the city is able to provide at a time when other municipalities are cutting services and staff.

Philip Gardner of 2100 Manning Road advised that although he resides in unincorporated Darien, he has been the grateful recipient of excellent municipal services. Mr. Gardner looks forward to annexing in the near future.

Mayor Weaver advised that Mr. Gardner is the beneficiary of many services because he lives on a road that is under the jurisdiction of the city.
