### January 29

#### Criminal Damage to Property

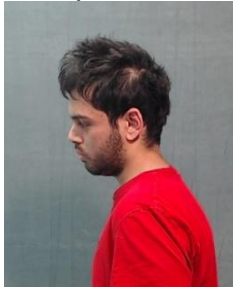
### January 30

#### Disorderly Conduct

At 3:02 p.m., officers were dispatched to the 7300 block of Evans Place for a suspicious incident. The complainant stated that her child and her child's friends were walking home from school and a subject yelled at them. The subject got into his vehicle followed them and swore at them. #### Domestic Battery
