### **Driving While License Suspended**

At 11:24 a.m., officers were on routine patrol on 75<sup>th</sup> Street at Williams Street when they performed a registration inquiry that came back as expired. A traffic stop was conducted at 75<sup>th</sup> Street and Adams Street. Cody Gilson, 32, of the 300 block of Washington Street, Joliet, charged with driving while license suspended and driving with an expired license plate. Gilson was issued a court date of April 16, 2026, at the DuPage County Judicial Center.

### **Driving Under the Influence of Alcohol**

At 8:49 p.m., an officer was dispatched to Elizabeth Ide, 2000 Manning Road, in reference to a hit and run traffic crash.
