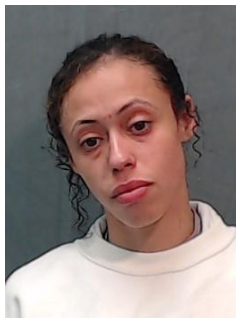

October 8

Domestic Battery

At 6:30 p.m. an officer responded to the Darien Police Department for a domestic battery that occurred in the 7400 block of Brookdale Drive, Darien. Stefan Radenkovic, 33, of the 8500 block of Washington Street, Downers Grove and Alize Carman, 30, of the 3900 block of 65th Street, Chicago were arrested for domestic battery and transported to the DuPage County Jail.



October 9

Retail Theft

At 12:11 a.m. an officer was dispatched to Speedway, 10250 Lemont Road in reference to a retail theft. The complainant stated that the offender entered the store and picked up three (3) 24-packs of Modelo and exited the store without paying while assisting another customer at the time. The offender is believed to be a repeat offender at this location. Loss \$113.94

Theft from Motor Vehicle

At 4:16 p.m. an officer was dispatched to the 9000 block of Darien Woods Court for a theft from motor vehicle report. The complainant stated that when she was getting ready to drive to work, she noticed her purse and a bag of makeup were missing from her unlocked vehicle. Driving Under the Influence of Alcohol

At 3:05 a.m. an officer on patrol on Cass Avenue and 75th Street observed a vehicle nearly strike the center median. While following the vehicle, the driver struck the right curb approximately four times between Williams Street and Lyman Avenue. A traffic stop was initiated and Silvia Delgado, 31, of the 2300 block of John Rolfe Drive, Schaumburg was arrested for driving under the influence of alcohol. Delgado was issued a court date of November 18, 2025 at the DuPage County Judicial Center.

Theft from Motor Vehicle

Someone outside noticed the driver's side window was broken and the door was left open on a vehicle. The officer located and spoke to the vehicle owner. The vehicle also had the front passenger window shattered, the hood to the engine left slightly open and items moved around in the glovebox. Loss \$300.

Driving While License Suspended

At 12:06 a.m. officers conducting patrol at the Speedway Gas Station, 10250 Lemont Road, observed a vehicle that did not have a registration plate attached to the rear of the vehicle. The vehicle circled the parking lot and left on 103rd Street. An officer followed the vehicle and the driver switched lanes without signaling. A traffic stop was initiated at Lemont Road and 99th Street. Hasaan Echols, 55, of the 1700 block of 71st Street, Chicago, was charged with driving while license suspended, no valid registration and failure to signal when required. Echols was assigned a court date of November 6, 2025 at the DuPage County Judicial Center. After further interviews with Echols, he admitted to being the repeat offender at the retail thefts that occurred at the Speedway, 10250 Lemont Road. Echols was charged with one count of burglary and transported to the DuPage County Jail. Total known loss \$1,274.98



Possession of Cannabis

At 11:00 a.m. an officer on stationary patrol observed a vehicle traveling at a high rate of speed go past him. When the officer was behind the vehicle, the passenger dropped an unknown object out the window. A traffic stop was initiated on 71st Street. The driver, Alexander Zamora, 19, of the 7300 block of Country Creek Way, Downers Grove was issued a citation for disobeying a traffic control device and the passenger, Brian Sawier, 19, of the 7500 block of Florence Avenue, Downers Grove was cited for possession of cannabis, possession of paraphernalia and littering. Sawier was issued a court date of November 6, 2025 at the DuPage County Judicial Center.
